New Business:

I asked that I would like someone to entertain a motion for the club to reimburse me the \$160.00 for the rifle.

Wayne made the Motion, John seconded the Motion, No Discussion. Motion was passed.

I announced that 2 days prior to the AZWINS I had an opportunity to purchase 2 case (50 pounds) of Goex powder for \$17.00 per pound with no other fees. All I could purchase was 30 pounds of 3 FFF for a total of \$510.00. I offered that if anyone would like to look at the powder it's also on my tailgate.

I asked again if someone would entertain a motion for the club to reimburse me the \$510.00 for the 30 pounds of Goex powder.

Matt and Tom ran the Hawk and Knife throw at the AZWINS and said they would provide pulled pork, buns and coleslaw for our 2020 Rendezvous. The Club will need to provide barbecue sauces while Members still bring some dessert cakes.
